AFENTRA PLC – CIRCULAR TO SHAREHOLDERS REGARDING NOTICE OF ANNUAL GENERAL MEETING

Please accept this letter as notification that Afentra plc (“Afentra” or the “Company”) has today issued a Circular to shareholders regarding Notice of the Company’s Annual General Meeting of shareholders. The Circular has now been published on the Company’s website at www.afentraplc.com. Unless the context otherwise requires, defined terms in the Circular have the same meaning when used in this letter.

Annual General Meeting Attendance

In order to facilitate attendance by Shareholders, the Annual General Meeting will be held electronically at 10.00 a.m. on 23 June 2026. If circumstances change such that it is necessary to change the arrangements for the Annual General Meeting, we will communicate such change via our website and (where appropriate) through the release of an announcement to a Regulatory Information Service. The Company will be operating an electronic voting system that will allow Shareholders to cast their vote on the Resolutions in advance of the Annual General Meeting. Shareholders will be able to cast their vote electronically via the Investor Centre app or web browser at <https://uk.investorcentre.mpms.mufg.com/> and following the instructions or using the CREST Proxy voting services. Electronic votes must be received by MUFG Corporate Markets by 10.00 a.m. on 19 June 2026.

The Company strongly encourages all Shareholders who wish to vote to utilise the electronic voting system to appoint the Chairman of the Annual General Meeting as their proxy (via (electronically via the Investor Centre app or web browser at <https://uk.investorcentre.mpms.mufg.com/> and following the instructions or using the CREST Proxy Voting Services).

Proxy Voting

You will **not** receive a hard copy form of proxy for the Annual General Meeting to be held on 23 June 2026 in the post. Instead, you will be able to vote electronically via the Investor Centre app or web browser at <https://uk.investorcentre.mpms.mufg.com/>. You will need to log into your Investor Centre account or register if you have not previously done so. Once you have setup your account you will need to add your shareholding by clicking ‘Add Holding’ in the ‘Portfolio’ section and following the on-screen instructions. You will require your Investor Code (IVC) to add your shareholding. You can find your IVC on your share certificate or by contacting our Registrar, MUFG Corporate Markets. Proxy votes must be received **no later than 10:00 a.m. on 19 June 2026.**
